RULES & REGULATIONS

DAKOTA WEST CREDIT UNION - CORE CONVERSION SHARE ACCOUNT DEPOSIT GIVEAWAY

No purchase necessary to enter or win.

- 1. Eligibility:** Giveaway (the "Giveaway") is open only to members who have signed up with a valid email address. Employees of Dakota West Credit Union (the "Sponsor") are not eligible to participate in the Giveaway.
- 2. Agreement to Rules:** By participating, you agree to be bound fully and unconditionally by these Rules, and you represent and warrant that you meet the eligibility requirements set forth herein. In addition, you agree to accept the decisions of Dakota West Credit Union as final and binding as it relates to the content. The Giveaway is subject to all applicable federal, state, and local laws.
- 3. Giveaway Period:** Entries will be accepted via email on or about Monday, May 13, 2019 and ending once twenty (20) correct responses have been received, but not later than May 31, 2019. All entries must be received by Friday, May 31 12:00 pm CDT.
- 4. How to Enter:** The Giveaway must be entered by replying to the email sent from Dakota West Credit Union on Monday, May 13. The entry must fulfill all giveaway requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules of specifications may be disqualified at the sole discretion of Dakota West Credit Union. You may enter only once and you must fill in the information requested. You may not enter more times than indicated by using multiple email addresses, or identities, in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Dakota West Credit Union.
- 5. Prizes:** Winners will receive one (1) of twenty (20) deposits of \$10 into his or her Dakota West Credit Union share account. No other prize substitution will be permitted except at the Sponsor's discretion. The prize is non-transferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes shall be the sole responsibility of the winner. Acceptance of prize constitutes permission for Dakota West Credit Union to use the winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.
- 6. Odds:** The odds of winning depend on the number of eligible entries received.

Winner Selection and Notification:** Winners of the Giveaway will be selected based on the date stamp provided when the email entry is received by the Sponsor and the fulfillment of the Giveaway requirements. Winners will be notified via email to the email address they entered the Giveaway within five (5) business days following the winner selection. Dakota West Credit Union shall have no liability for a winner's failure to receive notices due to winner's provision of incorrect or otherwise non-functioning contact information. If the selected winner cannot be contacted, is ineligible, fails to claim the prize within fifteen (15) business days from the time award notification was sent, or fails to return timely a completed and executed declaration and release as required, the prize may be forfeited and an alternate winner selected.
The receipt by winner of the prize offered in the Giveaway is conditioned upon compliance with any and all federal and state laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY ANY WINNER (AT SPONSOR'S SOLE DISCRETION) WILL RESULT IN SUCH WINNER'S DISQUALIFICATION AS WINNER OF GIVEAWAY AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.
